I. Purpose

The purpose of this Administrative Directive (ADM) is to issue final Calendar Year (CY) 2006 Per Diem Chargeback Rates for care provided to youth placed in facilities operated by the Office of Children and Family Services (OCFS).

Final CY2006 rates will be used as the basis for making adjustments to interim costof-care bills previously issued to localities for youth placed in OCFS-operated facilities and programs during CY2006.

II. Background

Chargeback rates for OCFS facilities are used to bill for the cost of care provided to youth placed in residential facilities and programs directly operated by OCFS. Rates used for such bills are initially calculated and billed as "interim rates" subject to a reconciliation of the actual expenditures for the period, and the determination of "final rates."

Localities are required to make payments based on interim rates that are charged to them on a quarterly basis in the OCFS quarterly cost-of-care bills. When final rates are determined for each level of care for a prior period, such rates are calculated based on the actual cost of care for that period, in accordance with Section 529 of the Executive Law. Bills that adjust the difference between interim and final rates approved for prior periods are issued to localities for care provided to youth for whom they are responsible.

III. Program Implications

A. Final CY2006 Chargeback Rates

Final CY2006 rates specified in this ADM have been approved by the State's Division of the Budget. They will be used by OCFS to bill the difference between interim and final rates for youth placed in OCFS facilities during the period of January 1, 2006, through December 31, 2006.

B. Final CY2006 Adjustments included in the 3rd Quarter Bill for CY2007

Adjustments for the four quarters of CY2006 (based on a change from interim to final rates for that period) will be included in the third quarter bill that is issued for CY2007 bills.

IV. Required Action

Chargeback bills for the third quarter CY2007 bill will include rate adjustments for CY2006 using the approved CY2006 final rates specified in this ADM.
